CBD compounding guidelines

Veterinary practitioners are authorised under all state-based drugs/poisons legislation to obtain, possess, use or supply scheduled substances for the treatment of animals in their care. A compounded preparation should only be used in circumstances where a registered product is unavailable or unsuitable, but as no CBD products are currently registered in Australia, there are no restrictions on veterinary compounding of CBD.

PetCann CBD compounding kits meet all Australian requirements, including:

· Veterinarians may only prescribe Schedule 4 medicinal cannabis products.

In Australia, veterinarians may only prescribe Schedule 4 medicinal cannabis products - meaning it must contain 98 per cent or more cannabidiol (CBD) and the total amount of other cannabinoids present must not exceed 2 per cent. Veterinarians are not allowed to prescribe Schedule 8 medicinal cannabis to animals in their care. Cannatrek's supply licenses in each state and territory permit the supply of CBD Isolate, a Schedule 4 substance, to registered veterinary practitioners.

· Veterinarians may only prescribe imported CBD

Only raw cannabis material or finished human cannabis medicine can be imported into Australia. The import of finished animal cannabis medicine is not allowed. Locally cultivated cannabis products cannot be used for animals as the Narcotic Drugs Act 1967 only covers the cultivation, production, and manufacture of medicinal cannabis for human use.

Why Cannatrek C100™ CBD Isolate Oil?

Cannatrek C100™ CBD Isolate Oil is made in the USA, so it meets the import requirement, and is a frequently prescribed Schedule 4 human CBD Isolate oil containing no THC. Each C100™ CBD Isolate Oil bottle contains 100mg/ml CBD Isolate formulated in a medium chain triglyceride (MCT) carrier oil. Not all human cannabis products are safe or suitable for use in pets as some contain high THC levels, are Schedule 8 or contain other ingredients that may be unsafe for pets such as xylitol. C100™ CBD Isolate Oil has been carefully selected because it meets all safety and legal requirements.
